

# COLUMBIA SHUSWAP REGIONAL DISTRICT

## BYLAW NO. 5550

A bylaw to amend South Shuswap Liquid Waste Management Plan Implementation Service Bylaw No. 5358

WHEREAS a local service area has been established by the Columbia Shuswap Regional District by Bylaw No. 5358, cited as " South Shuswap Liquid Waste Management Plan Implementation Service Bylaw No. 5358", for the purpose of implementing a Liquid Waste Management Plan;

AND WHEREAS the 2009 South Shuswap Liquid Waste Management Plan has been approved by the Minister of Environment;

AND WHEREAS the Board of the Columbia Shuswap Regional District has adopted the approved 2009 South Shuswap Liquid Waste Management Plan;

AND WHEREAS it is deemed desirable to amend Bylaw No. 5358 to incorporate a change to Schedule A to amend the service area to include all of Electoral Area 'C';

NOW THEREFORE the Board of the Columbia Shuswap Regional District, in open meeting assembled, HEREBY ENACTS as follows:

1. Schedule A of Bylaw No. 5358, cited as "South Shuswap Liquid Waste Management Plan Implementation Service Bylaw No. 5358" is deleted and replaced with the attached Schedule A.
2. That Section 3. of Bylaw No. 5358 be deleted in its entirety and replaced by the following:  
"The annual costs will be recovered by requisition of money to be collected by a parcel tax, which shall not exceed \$40/year per parcel."
3. That a new section 4. is inserted as follows:  
"The maximum amount that may be requisitioned annually for this service shall not exceed \$275,000."
4. That Section 4. of Bylaw No. 5358 is re-numbered as Section 5.
5. This bylaw may be cited as "South Shuswap Liquid Waste Management Plan Implementation Service Amendment Bylaw No. 5550."

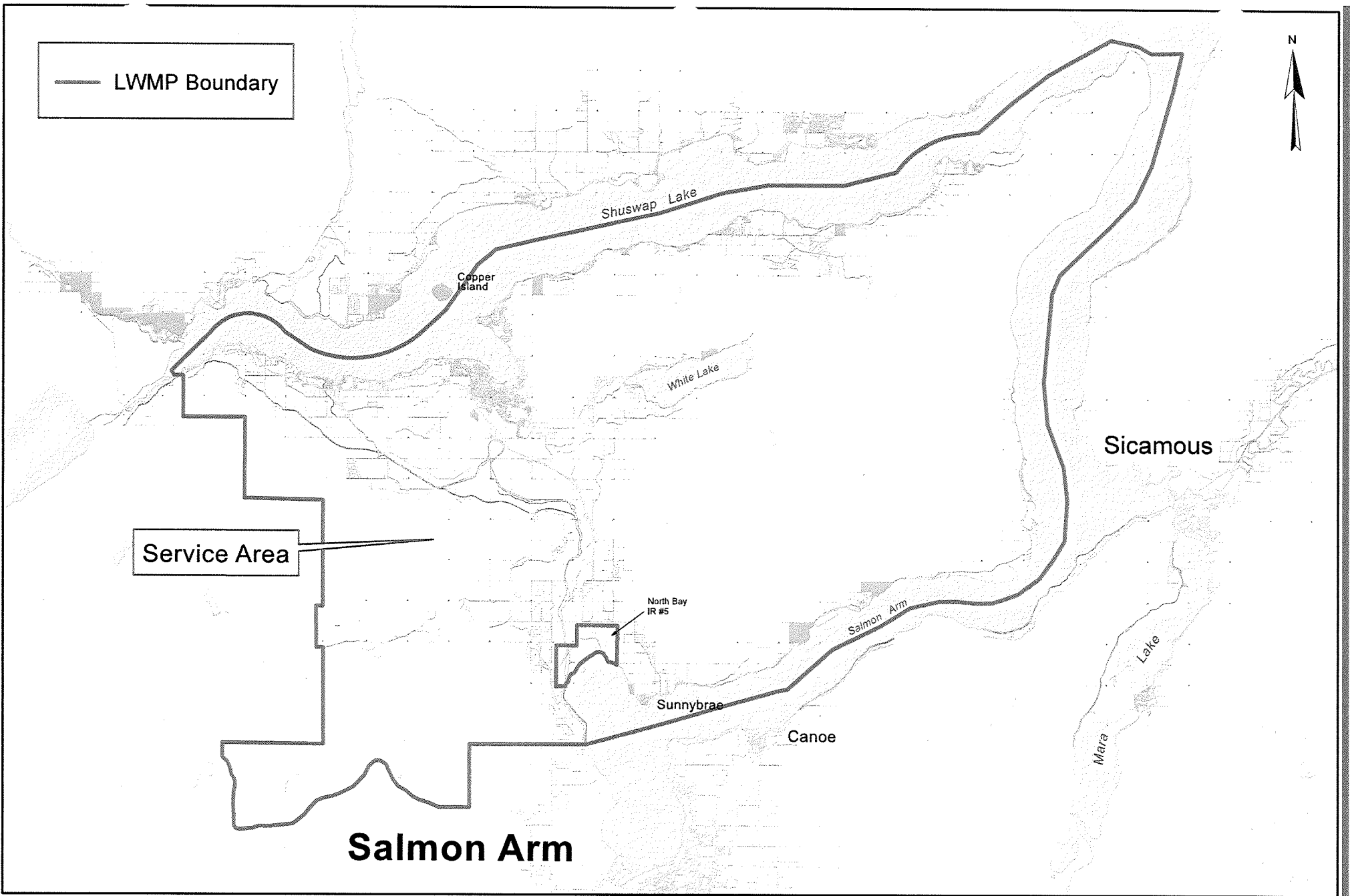
