# **DELEGATIONS**

CITY OF SALMON ARM – CURBSIDE FOOD WASTE TRIAL Jennifer Wilson, Municipal Engineer with the City of Salmon Arm, attended the meeting to present the results of a curbside food waste collection trial.

Ms. Wilson informed the Board on the goals of the City of Salmon Arm Curbside Food Waste Trial Project. Details were provided, as contained in a Powerpoint presentation included with the meeting agenda, on the following:

- Trial Period Specifics;
- Trial Area (variety of property sizes and uses and demographics);
- Collection Statistics:
- Trial Project Feedback;
- Success/Overall feedback from Residents.

Ms. Wilson added that the costs to move forward with a Curbside Food Waste program cannot be determined until a formal tender process is completed.

Ms. Wilson responded to several questions from the Board, advising that the City of Salmon Arm budget was \$25,000 for this trial project, and that the CSRD covered tipping fees, liners, etc.. Ms. Wilson thanked the Board and the CSRD staff for assisting in this project.

NEILSON-WELCH CONSULTING INC.

Allan Neilson was in attendance to review a report - Proposed Building Inspection Service – Business Case, dated October, 2016.

The Business Case explained the need for, and presented a complete outline of a proposed building inspection service for Electoral Areas B, C and E of the CSRD.

An overview of the report included:

- Chapter 1 (why building inspection is important and where it is provided):
- Chapter 2 (details of the proposed new building building service and the key elements associated with providing the service;
- Chapter 3 (how the service is established, including the legislative requirements and options for bylaw approvals, a suggested service start date of January 1, 2018, and the need for extensive community consultation).
- Next Steps: Choice between Options 1 and 2: Option 1 being a three standard inspections per permit regime; Option 2 a regime of six inspections. There is an alternative for the Board to choose a phased-in approach to implementation.

Mr. Neilson responded to several questions and comments of the Board, including information on the peer review (TNRD, FVRD, etc) he had done of those building inspection services/best practices; the need for a well-developed community consultation strategy particularly as this topic has been a controversial one in the past, for example in Electoral Area C.

- a 3 step versus a 6 step inspection standard;
- the need for community consultation also in Area F if the existing building inspection program expands from a 3 inspection to a 6 inspection standard;

- what would be a fundamental change to interactions with the public.

Staff have reviewed proposal(s) from Gateway Lakeview Estates and prepared the report attached to the Board meeting agenda. The latest proposal contains four solutions to deal with sewerage disposal/wastewater: lake outfall, rapid infiltration basins, reclaimed water reuse through drip-irrigation and a raised mound disposal area.

Letter dated October 17, 2016 from Gateway Lakeview Estates was circulated as part of the Board meeting agenda for information.

# **Discussion**:

 Comment that as a lay-person realizes it is not wise to add liquid to an area that floods; concerned about potential contamination of wells/drinking water in the area next to the development; drip irrigation proposed appears not be the best solution for development; large lots starting out as seasonal versus growing into year round use; unable to support the proposal and supports staff recommendations:

- Wants to see outfall out of the lake despite the fact that it is treated effluent - as he understands it even a high quality effluent would not remove certain influences (ie endocrine blockers, hormones, or pharmacological influences);
- Does not agree with rapid infiltration in a floodplain area;
- The raised sand mound approach in more areas than the Development Area 4 may be considered if proposed by the applicant;
- Unable to support proposal as presented with the variety of sewage disposal methods;
- Will not support any development with sewage into lake supports staff recommendations;
- 3 major concerns: flooding, affects on drinking water and putting treated effluent into the lake (all of which undermine everything that is being done by the Shuswap Watershed Council service);
- Current proposal is a patchwork of solutions to solve the discharge of treated effluent into the lake;
- · High public opposition at the Public Hearing;
- Applicant could take these comments under advisement;
- Onus is on applicant to re-evaluate their proposal and to bring forward a solution.

- Will lead to other applicants requesting oversize dock(s);
- Issue with 37 sq. m. size dock; need consistency with Provincial regulations and to minimize bylaw enforcement resources; these two things are at odds;
- Staff advised that the Province's size requirements and the CSRD's general size is the same, but for docks above the general size, a zoning amendment comes into play through the CSRD;
- Additional comment that an issue in this case is the walkway (no access to Crown land), versus the dock; wants to hear public feedback.
