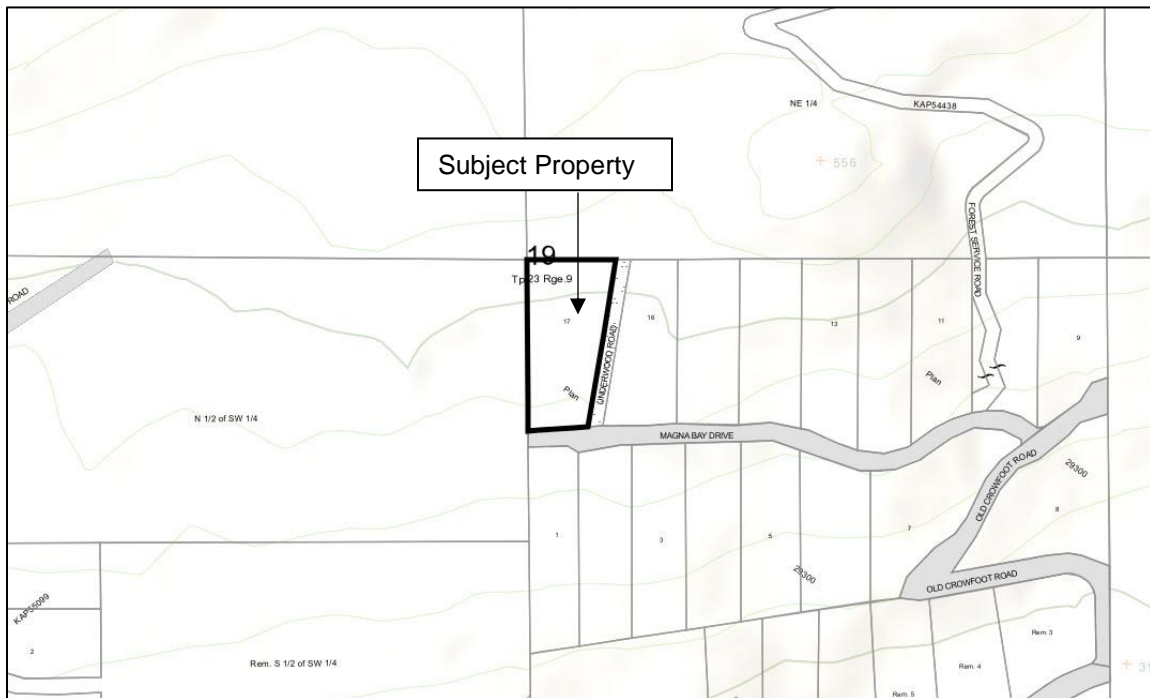
## NOTICE OF DEVELOPMENT VARIANCE PERMIT 800-29

### What is DVP 800-29?

The owner has applied for an 'After the Fact' Development Variance Permit for two new accessory buildings located on the property. 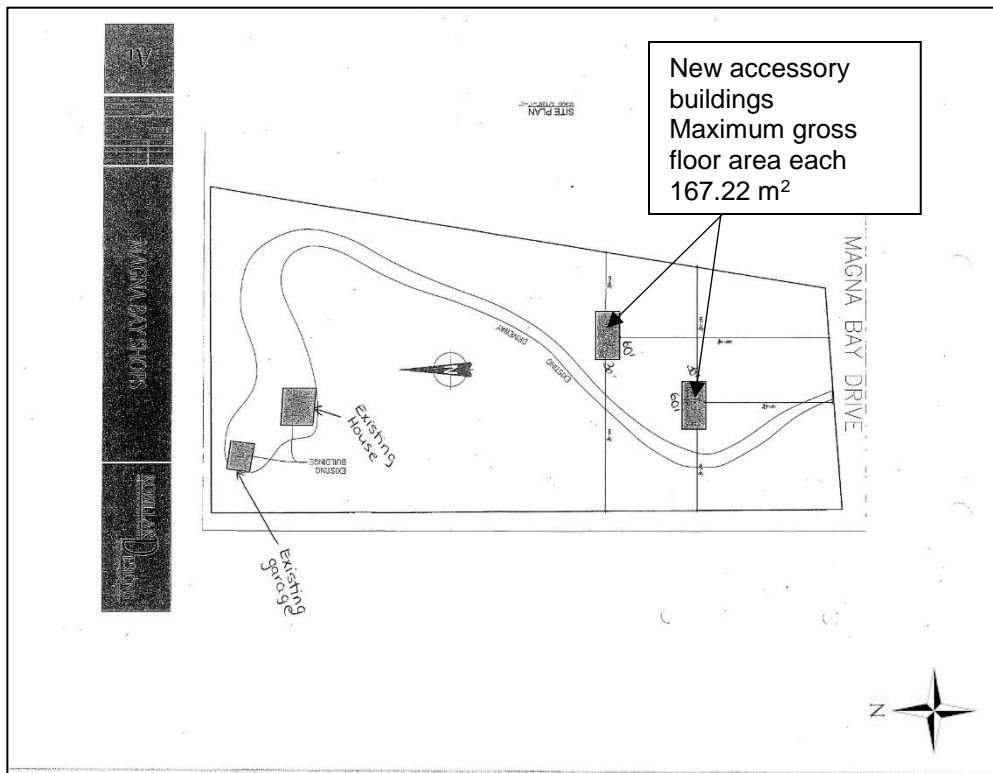
