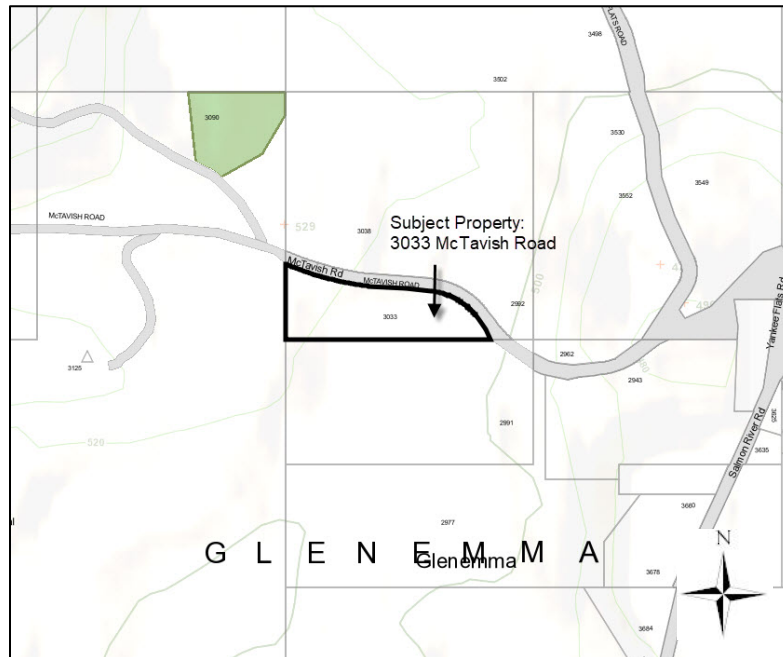

NOTICE OF TEMPORARY USE PERMIT NO. 2500-02

What is Temporary Use Permit No. 2500-02?
