Airport Manager's Report

Airport Manager presented a report to the Commission with an update on items
that have occurred at the Airport over the past year:

- Soil Remediation: the fuel vapours are being removed from the contaminated soil.
- Water Line Repair: water stop valves have been replaced, due to breakage, located in T-hangars.
- Airport Brushing: brushing completed in 2012 along the southwest corner and will commence October 2013 in the Machete Island area.
- Forestry Hangar: metal roof replacement was completed in early July.
- Perimeter Security Fencing: Phase 1 of the security fencing around the southwest corner of Airport runway has been completed.
- Airport Fuel Systems: Fuel tank inspections were completed and found to be in good shape. In the month of August there was an increase in Jet A fuel sales due to forest fire activities. Executive Flight Fuels did an excellent job delivering fuel daily to the Airport during the fires.

- Forestry Office Building: A new dry drain installed which will service three roof drains and work has been completed.
- Aircraft Hangars: 15 inquiries for covered hangars for the 2013/2013 winter season.
- Runway Markings: Refurbishing of the required runway markings is to be completed in late September 2013.

**2014 BUDGET

The Manager of Environment and Engineering Services presented the Revelstoke Airport Five Year Capital Financial Plan. The 2014 Capital items discussed are as follows:

Total planned Capital Expenditures 2014 **\$212,000**

*(contingent on \$300,000 grant from Tourism Infrastructure funding program)

Future capital projects were also discussed in the Five Year Financial Plan such as; an upgrade to the water main; runway widening; and an upgrade to the Airport Terminal building in order to accommodate scheduled passenger flights.
